The Company MFG. hereby certifies that the products manufactured and exhibited in Table 1 are in accordance with 105CMR 665.010, the products do not meet the definition of a flavored tobacco product or flavored tobacco product flavor enhancer, and that the product lacks any characterizing flavor in accordance with 105 CMR 665.005. The Company MFG product's nicotine content do not exceed 45 milligrams per milliliter.
