Additional Information:

USE We encourage visitors to take casual photographs for their own personal use without needing a waiver or fee. Our photography guidelines are for all guests, but posed photography requires an additional fee and waiver. The photographer does not need to be a professional. It is the responsibility of the photographer or videographer to obtain a waiver. If you are unsure of whether or not a photographer's fee applies to you, please consider:

1. Did you bring people to Taste to be photographed?
2. Are you here for the purpose of taking photographs of the people in your group?
3. Are you using Taste's grounds, facilities, or props as the backdrop for your photographs of people?
4. When you picked out the clothes you will wear, did you consider how they will look for your pictures?

If you are taking photography/videography for advertising or mass media purposes, please contact us in advance; we are happy to work with you.

RATES The photography fee is \$75 per hour unless the shop is required to close, in which case a fee of \$500 per hour applies.

LIMITS ON EQUIPMENT Photographer must provide all necessary equipment. Equipment should be limited to portable sizes that will not detract from other guests. No cords or ladders may be used.

CLEANING & TRASH Photographer and all associated with the photographer agree to leave Taste in the same condition as they were when they arrived. All items brought to the Premises are to be removed by the Photographer and associates. Items left after 7 days will be assumed abandoned and may be discarded with no compensation due.

AREAS ALLOWED Photographer will be given, within Taste's sole discretion, the possibility to take pictures in areas currently open to the public. Other areas of entrance need permission from the on-duty manager. No guests are allowed in employee only areas, buildings, or on or near equipment.

TASTE RULES:

- No smoking whatsoever anywhere on the premise.
- No alcoholic beverages or non-prescription or illegal drugs.
- Noise is to be kept at reasonable levels and not contain vulgar or offensive words.
- No pets or animals allowed at photo sessions.
- No moving any furniture or displays without the permission from staff.

CONDUCT Taste’s customers have priority in all situations. The Photographer and family/models shall not block them from going about their visit in any way in order to take photographs. The photographs shall not have any inappropriate content (nudity, vulgar, offensive). The photographer will not take photographs of Taste’s customers or staff without their approval. Photographer shall be solely responsible for the conduct and welfare of all persons accompanying Photographer while on Taste’s premises. Photographer agrees that a Taste representative may be present at any time. If the representative observes or otherwise becomes aware of dangerous, pornographic, illegal or negligent practices or activities, the representative reserves the right to stop the shoot and will require Photographer and Photographer’s party to leave immediately. In such case no refund will be given. However, Taste and its representatives assume no responsibility to act in such cases.

WAIVER OF LIABILITY Use of Taste’s premises is at the photographer and associated models/family/staff’s own risk. The photographer and all associated with his/her photoshoot hereby agrees that Taste Artisan Chocolate, LLC will not be held liable for any direct, indirect, incidental or consequential damage, injury or loss to people or possessions while on the Premises. The photographer and all associated with photographer holds harmless and indemnifies Taste Artisan Chocolate, LLC and its owners, agents, representatives, associates, officers, employees, guests and tenants against any suit, claim, loss, accident, judgment, fine, injury or damages, including reasonable attorney’s fees. This indemnification shall continue in full force and effect during and after the term of the rental for such causes arising during the term of the rental.

DAMAGE TO PREMISES: Photographer understands that if there is any damage to premises, furniture, product, or any other property owned by TASTE, due to any action on the part of the photographer and associates, the photographer and associates will be financially responsible. A credit card will be held on file for smaller incidents. If any legal action must be taken, all attorney’s fees, collection fees, or any fees associated with the monetary relief of TASTE, will be the responsibility of the photographer and associates. Any legal proceedings will take place in Provo, UT.
