13. TERMS & CONDITIONS

The following Terms and Conditions apply to your NRCA Stock Contractor's Insurance Affiliation

(Please read and select each text box to confirm your acceptance)

I UNDERSTAND National Rodeo Council of Australia (NRCA) has sourced this group insurance policy through an independent Australian Financial Services Provider (AFS) for the benefit of its members and affiliates.

I UNDERSTAND the NRCA Stock Contractors Policy I am about to renew only provides cover for the business activities of providing stock for rodeo events, schools and practice sessions, this includes the transporting, loading, unloading and general handling of livestock on route to and from a rodeo event and the handling of stock at the event grounds; the policy also provides cover for the set up and supply of portable seating, chutes and event arenas and the pre-event practice of the running of stock on our own property. These are the **ONLY** activities this policy provides cover for. There is NO cover under the stock contractors policy for the management, administration, running or organising of any event on behalf of an organising committee, a specific event related policy (general event public liability cover) needs to be taken out to cover the actual running of any event.

I UNDERSTAND Stock Contractors who are 'organising' a rodeo event (as well as supplying stock) MUST have public liability cover in place in ADDITION to this general Stock Contractor liability cover.

I UNDERSTAND that this policy provides cover for ONE nominated insured, either as a sole trader or a company or a joint venture (JV) *If a JV, it will only cover the activities of the JV and will not apply to business activities which I conduct outside of the JV. This insurance policy will only respond to the nominated insured's name should there ever be a claim or action taken against me in connection with the insured business activities. All other Contractors sub-contracting under the 'insured' Stock Contractor, are required to purchase or hold their own insurance policy to ensure adequate cover is in place.

I UNDERSTAND When I am supplying stock for a practice session which I am running/holding on my <u>own</u> property, that release and waivers MUST be signed by all participants and workers entering the arena (waivers supplied by NRCA on request). It is my responsibility to keep all waivers filed and recorded. ***This clause does not apply for any events where my services have been utilised to provide contract stock.**

I UNDERSTAND This policy does not have a Workers Compensation component and if I employ anyone in my business (where I pay PAYG tax to the ATO) I am required by law to hold an adequate Workers Compensation policy OR if I am using the services of a sub-contractor, I understand and acknowledge the sub-contractor should have their own work cover insurance in place. If no work cover insurances are in place, I understand a personal accident policy is required and can be supplied through the NRCA office on a per event basis.

I UNDERSTAND Personal Accident insurance cover MUST be provided to all <u>riders</u> participating in any practice day sessions where I have supplied stock and I am running the practice session on my own property and acknowledge it is my responsibility to submit a personal accident application to the NRCA office by fax or email PRIOR to supplying stock for any such event.

I UNDERSTAND AND ACKNOWLEDGE that I am bound to and will comply with the 'Standards For the Care & Treatment of Rodeo Livestock' in QLD, NT, TAS, WA and/or the Code of Practice for animals used in rodeo events in NSW and/or the Prevention of Cruelty to Animals (POCTA) Act 1986 and Prevention of Cruelty to Animals Regulations 2008 in VIC, whilst providing stock to the rodeo and western sports industry in these states. I understand this document may vary slightly from state to state and I CONFIRM that I have read and understand the contents of each state code, which apply to the areas I conduct my stock contracting business.
