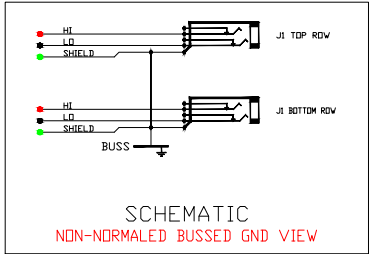
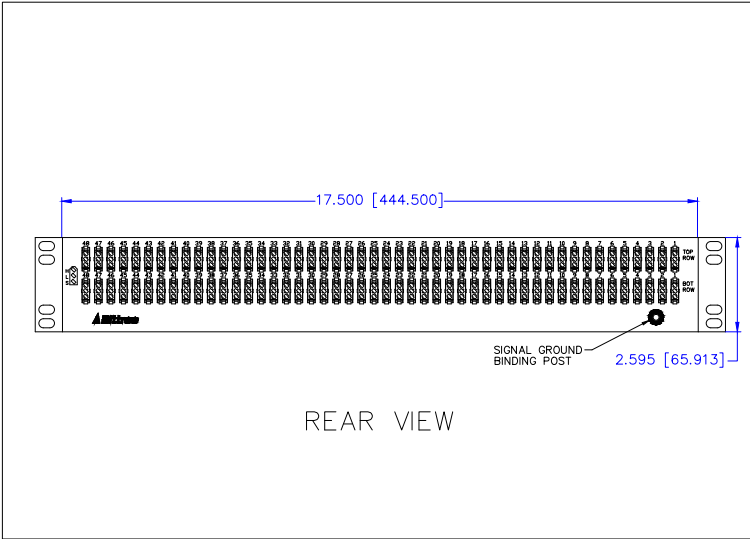




BITTREE 3 PIN CONNECTOR
REAR VIEW PIN-OUT



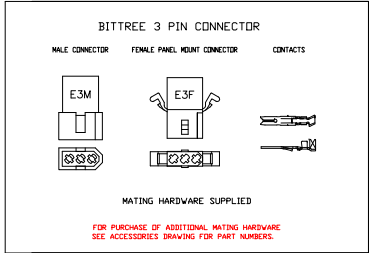
SCHEMATIC
NON-NORMALED BUSSED GND VIEW



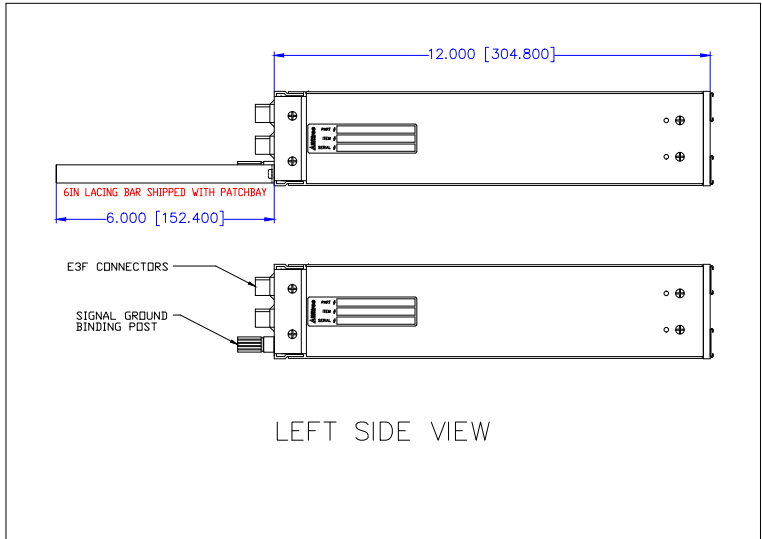

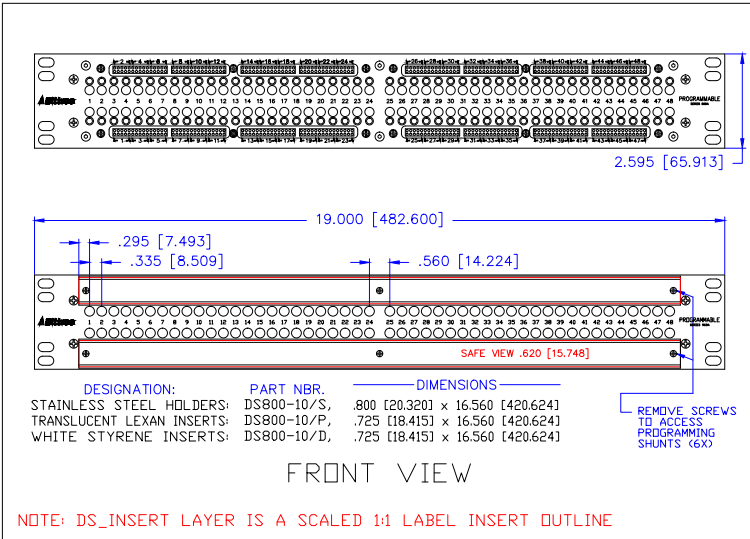
