# 1 INTRODUCTION

## 1.1 Background and Statutory Requirements

Asbestos comprises highly toxic, naturally occurring silicate minerals found in the surface of the earth, which have been extensively used commercially in the construction industry. Asbestos Containing Material or ACM is now a prohibited substance as it can cause a range of lung diseases that are often slow to develop but in many cases are deadly.

This Asbestos Management Plan (AMP) details how the asbestos management requirements for **ProjectTitle** will be implemented and managed on site by **CompanyName**.

The aim of the AMP is to ensure that health and safety risks associated with the project are properly managed. The following Legislation, Regulations and Codes of Practice have been used in the preparation of this AMP:

- Work Health and Safety Act 2011;
- Work Health and Safety Regulations 2017;
- Safe Work Australia Code of Practice - How to Manage and Control Asbestos in the Workplace
- Safe Work Australia Code of Practice - How to Safely Remove Asbestos
- Safe Work Australia Code of Practice - How to Manage Work Health and Safety Risks
- Safe Work Australia Code of Practice - Managing the Work Environment and Facilities

### **GUIDANCE NOTE**

**If asbestos or Asbestos Containing Material (ACM) is identified in a workplace and demolition or refurbishment work is to be carried out, the asbestos or ACM must be removed before the work starts if it is likely to be disturbed. If other maintenance or service work is to be carried out at the workplace, removal of asbestos should be considered as a control measure. Where removal is not reasonably practicable, other control measures must be implemented to minimise exposure, including encapsulation or sealing.**
