USING THE HEADPHONES

To use the BestBuds In-Ear Headphones, plug them into any device with a 3.5mm port and insert the earphones in your ears.



USING THE HEADPHONES

| То | Action |
|----------------------------------|-------------------------------------------------------------------------|
| Play or pause a song or video | Press the center button once. Press again to resume playback. |
| Skip to the next song or chapter | Press the center button twice quickly. |
| Answer or end a call | Press the center button once to answer. Press again to end the call. |
| Increase volume | Press the + button. |
| Decrease volume | Press the - button. |

While the BestBuds in-ear headphones are volume limited by design, if you would like further control over the volume limit you can use your device's built-in volume limiter and restrict the maximum volume. You can consult with your device's user manual or do a quick web query to locate the volume limit setting.

USING THE HEADPHONES

Please be sure to correctly wear the headphones by using the proper sized earbuds and correctly using the Left and Right earbud.

The interchangeable earbud covers should allow the earbud to sit flush to your ear. Please make sure that you have a good seal with your ear canal because this will significantly reduce outside noise. Also, if it's not sitting in your ear properly the music might sound low, lacking of bass, or "tinny." As always, please contact us at support@lilgadgets.com with questions or concerns.

If you need to clean the product, please use a dry and soft cloth.

We included our SharePort® Splitter so you can easily share your music or games or movies with your friends and family. When using the splitter, some of the features of the BestBuds inline remote might be disabled by the tablet, phone or computer operating system. For example, in iOS, the play/pause will still work but the volume can only be controlled on the tablet or smartphone and not the BestBuds.
