

Welsh Government Introduces New Workplace Recycling Legislation

From 6th April 2024, it will become law for all businesses, charities and public sector organisations to sort their waste for recycling.



What Needs To Be Separated

- Food
- Paper and card
- Glass
- Metal, plastic and cartons
- Unsold textiles
- Unsold small waste electrical and electronic equipment (sWEEE)

You can mix paper and card together in the same container, and you can mix metal, plastic, and cartons together.



Plus a Ban on...

- Sending food waste to sewer (any amount)
- Separately collected waste going to incineration and landfill
- All wood waste going to landfill

Who the Law Applies To

- Agricultural premises
- Hospitality and tourism
- Showgrounds
- Service stations and petrol stations
- Entertainment and sports venues including leisure centres
- Transport
- Care and nursing homes
- Pharmacies, GP surgeries, dental surgeries, and other primary care settings
- Construction sites
- Factories and warehouses
- Car garages
- Education
- Garden centres
- Heritage buildings
- Libraries and museums
- Offices and workshops
- Places of worship
- Prisons
- Outdoor markets and festivals
- Retail

The only workplace that has an additional 2 years to comply is NHS hospitals and private hospitals.

1 racksack®

Segregate waste packaging materials as you go. Fits roll cages by hooking over the sides or can be secured via eyelets in the top corners. Straps help secure the middle of the sack. Ideal for 800mm wide roll containers. 1,300mm (H) x 880mm (W).

6 racksack® trolley



Ideal for hooking onto handles of picking trolleys up to 580mm wide, or secure via eyelets in other locations. Available in either single or double pocket versions. 750mm (H) x 600mm (W).
