Consignment Agreement

1. This Consignment Agreement (“Agreement”) made on this Date _____ is by and between Designers on a Dime (Consignee) having a business address of 1321 Upland Drive #6059 Houston, TX 77043 and email address of: customer@designersonadime.com, and (Name) _____ (Consignor) having an address of _____, and an email address of: _____. This Agreement when signed electronically will have the same force as an Agreement that is signed in person, and, will constitute the entirety of the Agreement. This agreement is for 1 (one) year.
2. The Consignee is engaged in the business of selling Authentic Designer Brand Fashions across a Network of over 53 (fifty-three) Shopping Platforms, and has agreed to accept from Consignor an article(s) to sell across the network.
3. The Consignor will submit the proposed consignment article(s) for sale via the online form or through direct contact with the Consignee. Upon acceptance by the Consignee, the Consignor will execute this agreement and receive a prepaid label to ship the article(s) to be consigned to the designated location of the Consignee.
4. Upon acceptance of the article(s) by the Consignee, an inspection of the item will be done to verify its authenticity, condition and value.
5. Any misrepresentation of the authenticity or condition of the article(s) will void this Agreement. In the event an item is deemed to be a counterfeit, or the condition is misrepresented, it shall be the responsibility of the Consignor to pay in advance for return shipping.
6. Upon a completion of the inspection for authenticity, damage, and condition the Consignor will receive an executed copy of this Agreement signed by the Consignee along with an account number for tracking and payment.
7. The Consignee will clean, photograph and list the consigned article(s) for sale at the appraised retail price. All costs associated with the sale and shipping of the consigned article(s) will be an expense of the Consignee. The Consignor shall bear no expense in the presentation, sale, or shipping of the consigned article(s)
8. The Consignor will receive 50% (fifty percent) of the actual retail sale price of the item, this does not include any shipping or handling charges that are charged to the buyer.
9. The Consignee shall bear all administrative and processing fees in relation to the sale of the consigned item. The Consignee will insure the item that is consigned from the time of acceptance to the time of sale at the listed retail price at the time of loss or damage.

10. The item will be placed for sale and promoted by Designers on a Dime for 60 (sixty) days across their selling network of 53 (fifty-three) shopping platforms, and any additional ones that may join the network while this agreement is in force.
11. After 60 (sixty) days, the retail selling price of the item will be reduced by 10%. The reductions will continue every 60 (sixty) days until the item is sold. The Consignor will receive 50% (fifty percent) of the actual retail sales proceeds at any time throughout this 1 (one) year Agreement.
12. If at the end of 1 (one) year, the term of this agreement, the item has not sold, it will become property of Designers on a Dime, The Consignee; unless the Consignor request a return and prepays for return shipping. Please check one box below:
 - NO, I DO NOT WANT MY CONSIGNED ITEMS BACK.
 - YES, I WANT MY CONSIGNED ITEMS BACK AND AGREE TO PROVIDE A CREDIT CARD TO COVER THE SHIPPING COSTS OF SENDING THE CONSIGNED ITEMS BACK TO ME.
13. Designers on a Dime, The Consignee, by signing this Agreement, agrees to use all due diligence and industry expertise to sell the item at the highest retail price in as timely a manner as market conditions allow.
14. Consignor will receive 50% (fifty percent) of the retail sales price of their consigned item within 45 days (forty-five) of the sale of their consigned item. Consignor will receive payment via this method (check one) Paypal Check mailed by Consignee to Consignor
15. This Agreement, once in force by both parties, can only be amended by the written agreement of the signing parties jointly.
16. The terms contained in this Agreement are the entirety of the Agreement. There are no verbal warranties or claims.
17. This Agreement can be voided if the Consignor submits a fraudulent or counterfeit item.
18. This Agreement shall be bound by the Laws of the State of Texas.
19. If any clause of this Agreement is found unlawful, it shall not void any other binding clauses.
20. By affixing an electronic signature and date below, both parties agree that this Agreement is whole and in force for a period of 1 (one) year.
