In addition to the great success of the new Enrichment Courses (one credit/one week courses, often on contemporary topics), what has been particularly encouraging has been the uptick in the number of MA candidates into the program. So let me take this opportunity to thank those provincials and congregational ministers who have either encouraged or given permission to their friars and sisters to come to the Institute to learn about our great and common tradition!

Our new Academic Program Booklet for 2008-09 is now in the mail, making its way to a friary or convent near you, as well as overseas into the English-speaking world! We take very seriously our mission to provide the Franciscan Family with a knowledge of the charism of Francis and Clare and have worked hard to improve our programming in terms of content and options on and off campus – all within the limits of our available resources.

SCOTUS CONFERENCE


Three years in the planning, the Quadruple Congress - a series of four international conferences on the thought of Bl. John Duns Scotus in commemoration of the 700th anniversary of his death - held its inaugural conference on 18-21 October 2007 at the Franciscan Institute. This first of four conferences was conceived and organized by Sr. Mary Beth Ingham, C.S.J., Dr. Timothy B. Noone, and Fr. Michael F. Cusato, O.F.M. and was dedicated to the theme: the opera philosophica of the Subtle Doctor. The other three conferences will be held at Oxford University (21-24 July 2008, on the opera theologica); Bonn and Cologne in Germany (5-9 November 2008, on the metaphysics and ethics of Scotus); and it will conclude in Strasbourg, France (18-22 March 2009, treating the influence of Scotus's thought through the ages).

Special events included a Roundtable which gathered four of the scholars involved in the preparation of the critical edition of the

opera philosophica of Scotus: Dr. Girard Etz-korn, Fr. Romuald Green, O.F.M., Dr. Robert Andrews and Dr. Timothy B. Noone. The edition had initially been begun in the late 1980s at the Institute and was brought to a successful conclusion under Dr. Noone's direction at The Catholic University of America. All five volumes can be purchased through Franciscan Institute Publications.

By all accounts, this first conference was an overwhelming success. Thanks to the flawless organizing and tireless work of the staff of the Franciscan Institute and thanks to the resplendent colors of the Fall season at its peak moment, Conference I will long be remembered not only as a grand and fitting kick-off to the series, but also as a signal event in scotistic studies at the beginning of this century. The conference papers are to be published in several volumes as a co-publication between Franciscan Institute Publications and the German academic printing house Aschendorff. See you in Oxford!

The purpose of the Quadruple Congress is, on the occasion of the 700th anniversary of the death of Duns Scotus, to gather international scholars to celebrate the life, work and intellectual legacy of the Subtle Doctor.

Conference Highlights

Featured speakers during this celebration included Girard J. Etzkorn, Prof. Emeritus, The Franciscan Institute, Marilyn McCord Adams, Oxford University and Trent Pomplun of Loyola College.

Allan Wolter enjoyed great prominence in the international scholarly world, but was also a man of authentic Franciscan simplicity. When asked what attracted him to devote his energies to the works of John Duns Scotus, Allan replied that it was Scotus's idea of the Incarnation as the supreme act of creation. Father Allan now communes with John Duns Scotus face-to-face, having entered eternity November 15, 2006.

This first conference of the Quadruple Congress consisted of 20 presentations offered by some of the most pre-eminent scholars of the philosophy of Duns Scotus. Approximately 80 participants enjoyed sessions around three particular emphases: What made Scotus a specifically Franciscan philosopher? a celebration of the lifetime achievement of the late Fr. Allan B. Wolter, O.F.M. and the public recognition of the conclusion of the critical edition of the *opera philosophica* of Scotus.





Saturday evening presented an opportunity for the conference participants to celebrate Eucharist together in the University Chapel. Fr. Joseph Chinnici, O.F.M. was celebrant and homilist. Following the liturgy, all gathered for cocktails in the Doyle Dining Room which was followed by a formal dinner. The evening's program included the awarding of the 21st Franciscan Institute Medal to Dr. Ludger Honnefelder. Dr. Mary Beth Ingham gave the *Laudatio* and Dr. Honnefelder then spoke on "Franciscan Spirit and Aristotelian Rationality: John Duns Scotus' New Approach to Theology and Philosophy."

The closing session of the Conference took place in the Hall of Fame Room in the Reilly Center and featured the presentation of "Scotus' Approach to Logic and Metaphysics" by Giorgio Pini of Fordham University. 2007 SUMMER HIGHLIGHTS





The summer lecture series presented opportunities for exposure and inquiry into recent research on a variety of Franciscan topics. The first lecture presented by Dr. Louisa Burnham of Middlebury College was titled "Iconographical Images of Spiritual Franciscans in an Italian 14th Century MS." Dr. Burnham's talk focussed on the unique iconographical images found in a 14th century vernacular Italian manuscript of Angelo Clareno's *Chronicle of the Tribulations of the Friars Minor*. The centerpeice of her talk was the representation of the four Spiritual Franciscan friars burned at the stake in Marseille in 1318. (The Institute has made a pull-over shirt featuring this representation.)

The second lecture of the series brought Dr. Gert Melville to St. Bonaventure. Dr. Melville is director of the FOVOG at the Universität Eichstätt. His presentation compared different approaches to poverty and eremitism of the 12th century lay hermit, Stephen of Muret, and the 13th century lay itinerant, Francis of Assisi.

The Eucharistic Liturgy for the Feast of St. Bonaventure was celebrated in the University Chapel, Doyle Hall. Fred Link, O.F.M., provincial of St. John the Baptist Province, presided at the liturgy and Fr. Frank Lane of the Josephinum was the homilist. Regis Armstrong, O.F.M. Cap., Wayne Hellmann, O.F.M. Conv. and Bill Short, O.F.M., shown here participating in the liturgy, are well-known to Franciscan students as the general editors of the *Francis of Assisi: Early Documents* volumes.

2007 Franciscan Institute Medal Winners

Fr. Regis Armstrong, O.F.M. Cap. became the 20th recipient of the Franciscan Institute Medal at ceremonies held during the university-wide celebration of the Feast of St. Bonaventure.

Following Vespers on Sunday, July 15, 2007, Michael F. Cusato, O.F.M. presented the medal to Fr. Regis during the Academic Convocation in the Regina A. Quick Center for the Arts. Br. Bill Short, O.F.M. served as emcee for the program and Fr. Wayne Hellmann, O.F.M. Conv. delivered the *Laudatio* in praise of Fr. Regis's lifetime work in Franciscan studies. Sr. Margaret Carney, O.S.F. made closing remarks.


Fr. Regis is perhaps best known for his work on *Clare of Assisi: Early Documents* and as one of the three general editors of *Francis of Assisi: Early Documents*. He has written and/or translated nine books and authored many journal and encyclopedia articles.

Fr. Regis received his master of divinity and master of theology degrees from the Capuchin Seminary, a master of education from Iona College and a doctorate from Fordham University. He taught summers at the Franciscan Insitute and is currently a professor in the School of Religious Studies at The Catholic University of America in Washington, D.C.

On Saturday, October 20, 2007, within the context of the Scotus conference, the 21st Franciscan Institute Medal was awarded to Dr. Ludger Honnefelder. Dr. Honnefelder is currently the director of the Albertus-Magnus-Institut and the coordinator of Conference III of the Quadruple Congress honoring John Duns Scotus in November 2008. Dr. Honnefelder has served on the Theological Faculty in Trier from 1972-1982, was professor of Catholic Theology and Philosophy at the Free University of Berlin from 1982-1988, and since 1988, has lectured and taught at the University of Bonn. He has been a member of numerous committees established to develop a biomedical ethics based on Catholic teachings.

The Award Ceremony took place following a formal dinner in the Doyle Dining Room. Michael F. Cusato, O.F.M. was emcee. Dr. Mary Beth Ingham, C.S.J. gave the *Laudatio*. Dr. Honnefelder presented a magisterial paper on "Franciscan Spirit and Aristotelian Rationality: John Duns Scotus' New Approach to Theology and Philosophy."

The Franciscan Institute established the medal in 1987 to honor scholars who have made outstanding contributions to Franciscan studies in the areas of philosophy, theology, history and spirituality.

In Memoriam



FR. J. GREGORY BRENNAN, O.F.M., was remembered at his August 25 funeral as a quiet and gentle priest who made a difference in the lives of everyone he met. "Look at all of these people," said Fr. Richard Flaherty, O.F.M., gazing out at more than 500 people who filled St. Mary of the Angels Church in Olean. "You'd think we were burying a cardinal. But we're not. We're burying a wonderful brother."

A native of Troy, NY, Fr. Greg was ordained in 1979 and served St. Bonaventure University and was pastor at St. Pacificus Church in Humphrey for the past 21 years. An active member of the local community, Fr. Greg served as chaplain and volunteer to fire departments in neighboring Olean and Allegany, and as chaplain for 21 years to the Ancient Order of Hibernians (AOH) chapter in Olean. He was also a member of the executive committee of Allegany Boy Scout Troop 677, the Knights of Columbus

of Allegany and a former chief chaplain of the New York State Association of Fire Chaplains.

Sr. Margaret Carney, O.S.F., S.T.D., president of the University, said Fr. Greg was able to perform a "very grueling" administrative task and still maintain a "vibrant, human joyful outreach. He represented something wonderful for this community, and, of course, for our University."

Fr. Greg's brother, Joe Brennan, said he and other family members had been moved to learn how much Fr. Brennan meant to those who knew him. Joe Brennan said he was shown a scrapbook by a St. Pacificus parishioner that included pictures of his brother in his many roles as friend and volunteer. "One of his greatest gifts, I've come to find out, was just being there, being a presence," said Joe Brennan. "I wonder how many family photo albums have pictures of Fr. Greg. He was family to us all."

Fr. John O'Connor, O.F.M., minister provincial of Holy Name Province, said the packed church demonstrated the size of Fr. Brennan's extended family – "the family of all those who Greg ministered to in so many different ways over so many years."

Fr. Greg died in a drowning accident on the Allegheny Reservoir. After the funeral service, Fr. Greg's casket was placed on the back of an antique Allegany Fire Department fire truck for the procession to St. Bonaventure Cemetery, where he was buried.


will see another session on Islam using Clare's image of the mirror as the central organizing motif for the Forum. So mark your calendars and check out the Forum information on our website!

I am also pleased to report to you another development in our programs of instruction. Over the past years, the faculty of the School of Franciscan Studies has become aware that a number of our most promising students had expressed the desire to continue their study of the Franciscan tradition after completing their Masters degrees. Unfortunately, the Institute does not offer a doctoral program – otherwise they would have been very keen to continue their studies with us, benefiting from the expertise of our faculty (both resident and summer) and of our incomparable library resources. In response to these expressed desires, we are now opening up two new avenues to our students - both current as well as degreed - whereby they can deepen their studies of the tradition.

The first option is the result of a new cooperative venture between the Institute and the FOVOG (an Institute for the Comparative Study of Religious Orders in the Middle Ages) at the Universität of Eichstätt (southern Germany). The Director of that Institute, Dr. Gert Melville, is not only a good friend and colleague of the faculty of the Franciscan Institute but he also delivered an exceptional lecture here last summer during the Summer program. Together, we have arranged to offer to three of our students (two recent graduates and one candidate) the opportunity to take a course on medieval religious movements this June in Eichstätt. The course will be taught in English and fully funded by an agency in Germany desirous of promoting an understanding of religious issues. In exchange, the Institute will soon welcome one of Dr. Melville's students for a semester into our program. If you are interested in exploring such an opportunity in the future, by all means contact us! It is a great opportunity!

Finally, we are also working on an arrangement whereby students who registered in PhD programs in other universities but who are interested in Franciscan subject matter can come to the Institute, especially during the summer, to study with a member or members of our faculty in tutorials or actual coursework which will help them in their doctoral work. At present, the details of one such arrangement - with St. Louis University - are being worked out with Wayne Hellmann, O.F.M. Conv., dean of the Graduate School of Theology. This concept of a "Virtual Franciscan Academy," drawing upon the wealth of experience and expertise of our own faculty and colleagues from around the country (if not the world), is another exciting new venture we are exploring in order to make known the transformative forma vitae of our tradition - an alternative vision of Christian life so much in need in our world today!

THE RULE OF THE FRIARS MINOR: HISTORICAL PERSPECTIVES, LIVED REALITIES

To commemorate the 800th anniversary of the traditional date of the approval by Innocent III of the *propositum vitae* of Francis and his early friars (April 16, 1209), the Franciscan Institute is organizing a conference that will gather together medieval historians as well as contemporary practitioners of the Franciscan Rule in a three day event of interaction between April 17-19, 2009.

This conference will have a two-fold purpose.

First, it aims to gather some of the finest scholars in the English-speaking world to share the latest scholarship on the growth, development and evolution of the Early Rule in the life of the early fraternity. To this end, Dominic Monti, David Flood, Bill Short, Michael F. Cusato, Michael Blastic and Jean François Godet-Calogeras have been invited to present their insights on the formation and expansion of the text of the Early Rule.

Second, the conference will also gather a representative group of Franciscans from across the world to share their lived experiences of professing the Rule within a variety of different cultural contexts today. To this end, it is the hope of the organizers to have friars from continental Europe, the United Kingdom, America, Africa, Asia, the Middle East and Oceania present on the campus of St. Bonaventure University to share their experience of living out the charism of the Rule in diverse and challenging contemporary contexts.

The uniqueness of the conference is to gather, perhaps for the first time, scholars and practitioners of the Rule in a weekend of presentation, discussion and interaction whereby scholarly research informs contemporary praxis and current experience sheds light on the historical attempts of Spirit-inspired people to set down in writing statements of intention and rules of life. More details will be made available here in these pages as well as on the Institute webpage as the specifics of the conference are planned.

Summer 2008 Enrichment Courses

Continuing the recent development of providing special courses, one week in length, on topics which complement the regular curriculum and provide some in-service and updating for Franciscans in a variety of ministries, the Franciscan Institute is pleased to present the following opportunities for the Summer of 2008.

Robert J. Karris, O.F.M. will lead a weeklong excursion into Bonaventure's *Commentary on Luke* from June 23-27, 2008.
