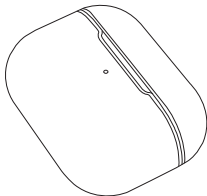
Reminder

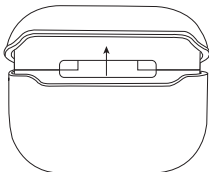

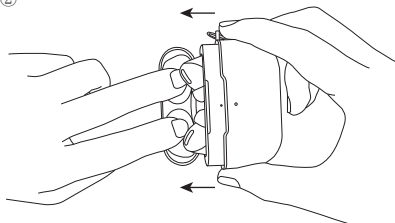
