TERMS AND CONDITIONS

The promoter is TWS Wholesale Pty Ltd

1. Instructions on "How to Enter" form part of these Conditions of Entry.

How to enter:

- a. Entry is open to all customers of TWS Wholesale Pty Ltd, other than employees and their immediate families of the Promoter, and their related companies and agencies associated with this promotion. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.
- b. Entry is made by: customers making a purchase of 6 bottles of more wines worth \$120 or more, either straight or mixed, on November 20 2018 and December 7 2018

2. Entry instructions and prize information form part of these Terms and Conditions. By participating, entrants agree to be bound by these terms and conditions, entries on 20.11.2018 and 07.12.2018 (NSW time) ("Promotion Period")..

- e. Prize pool:
 1. One entry will be received for each customer making a purchase of 6 bottles of more wines worth \$120 or more, either straight or mixed, during 2 promotional periods in November and December 2018.
 2. 1 in 50 customers whom makes a qualifying purchase will win a Free bottle of Grant Burge Meshach Shiraz RRP \$200
 3. Total prize value equals \$10,000 (including GST) for 50 prize giveaways.
 - Prize Draw and notification details:
 - I. Customers whom purchase 6 bottles of more wines worth \$120 or more, either straight or mixed, on November 20 2018 and December 7 2018 will be randomly selected to receive the prize with 1 prize given out for every 50 entries. This draw will take place on the day after the two competition days on November 21 and December 8 respectively.
 - II. Notification date will be on November 21 and December 8 respectively (phone).
 - III. The re-draw date will be Monday 7 January 2019 (if required).
 - IV. The re-draw notification date will be Monday 7 January 2019 (if required).
3. Entries into the draw close midnight (NSW time) on November 20 2018 and December 7 2018 . All prize draws are to be conducted at 66 Bay St, Ultimo, NSW, at 10am (NSW time) as mentioned above. The winners will be notified by phone and the prizes sent out immediately.
