

**SUPERTUNER 240SX GIVEAWAY  
OFFICIAL RULES  
NO PURCHASE NECESSARY. PURCHASE OR ACCEPTANCE OF  
A PRODUCT OFFER WILL NOT IMPROVE YOUR CHANCES OF WINNING.**

The Supertuner Giveaway (the "Giveaway") and any advertisement relating thereto is intended for participation only by legal residents of the 50 U.S. and D.C. This Giveaway shall be construed according to, and governed exclusively by U.S. law. Do not participate in this Giveaway if you do not fall within the eligibility requirements set forth below.
