

## HAGGARD RACING X FIFTEEN52 COLLABORATION SWEEPSTAKES

### OFFICIAL RULES

#### NO PURCHASE NECESSARY

- PROMOTION PERIOD:** The Haggard Racing X Fifteen52 Collaboration Sweepstakes (the "Sweepstakes") begins at 12:00:00 AM EST on 8/1/2017 and ends at 11:59:59 PM EST on 8/31/2017 (the "Promotion Period"). Sponsor's computer is the official time-keeping device for the Sweepstakes.
- ELIGIBILITY:** This promotion is open only to legal residents of the 50 United States and the District of Columbia and residents of Canada (excluding Quebec), who are 16 years of age or older. Void in Quebec and where prohibited. Employees of Haggard Racing Co., its affiliates, subsidiaries, advertising, promotion and internet agencies (collectively "Released Parties") and their immediate family members (spouse, parent, child, sibling, grandparent) and/or those living in the same household of each are not eligible. All federal, state, municipal, provincial and local laws and regulations apply.
- HERE'S HOW IT WORKS:** During the Promotion Period you will automatically receive one (1) entry into the Sweepstakes for every \$10 spent on an eligible purchase at [www.haggardracing.com](http://www.haggardracing.com) (the "Website") (e.g., a \$30 purchase will earn 3 entries). The number of entries you receive will be based on the net price of your eligible purchase (i.e., list price minus any discounts, refunds, returns, credits and/or shipping charges) and will NOT be rounded to the nearest \$10 (e.g., a \$50 purchase that is reduced by a \$15 discount will earn 3 entries). Your purchase transaction must be received by 11:59:59 PM EST on 8/31/17 in order to be eligible to receive entries.

To enter without making a purchase, on a plain piece of 3"x5" paper, hand print your first and last name, street address city, state, zip code, date of birth (mm/dd/yyyy), e-mail address plus daytime telephone number including area code. Then, on the opposite side of your entry, in 25 words or fewer, complete the following sentence: "I want to win the X Fifteen52 Collaboration Sweepstakes because... ."
