Job Summary: Niroga's Dynamic Mindfulness Instructor will teach Dynamic Mindfulness in Niroga programs in assigned TK-12 schools and/or Juvenile Hall in Alameda County, Contra Costa County, and/or San Francisco County.

RESPONSIBILITIES

- Learn about the science and practice of Niroga's Dynamic Mindfulness (DMind) approach
- Confidently and effectively teach trauma-informed Dynamic Mindfulness (DMind) to individuals, small groups, and large groups of varying ages, including students from TK-12 and/or juvenile hall, and staff at partner sites
- Coordinate all aspects of program delivery at designated partner sites (e.g. teaching, training, coaching, providing support products, etc.)
- Develop, nurture and sustain relationships with leaders at partner sites
- Assist with participatory program evaluation to ensure program impact
- Support with other areas or sites as needed to maximize impact
