

GPS Quick Start Guide

Thank you for purchasing your UFM or UFH real time trackers from our Spy Centre Security website. We want to make the activation process as easy as possible.

Please email or fax the included paperwork back to us at **214-291-5944** or scan and email to: Sales@spycentre.com to complete your activation process. If we receive your paperwork before 4PM CST, your tracker will be activated the same day. If your paperwork is received after 4PM CST your tracker will be activated by the following morning.

The credit card you provide will be charged a prorated amount for the current month. For example, if your tracker is activated on October 15th, you will be charged a prorated amount (\$1.33 per day) for October 15th to October 31st. It would be \$1.33 per day x 17 days of service = \$22.61 prorated amount for October.

You will be charged on the 25th of each month until we receive notification from you to cancel your service. The monthly service is \$39.99 per month. We need to receive the cancellation request on or before the 25th of the month and we will cancel your service for the following month. There is no cancellation fee, but if you do want to reactivate your tracker you will pay \$29.99 to reactivate the tracker. The cancellation request must be done in writing and be sent from the email address we have on file.

If the charge for your monthly service is declined, we will attempt to contact you at the email address and/or the phone number you provided. If you do not want to be contacted for any reason please make sure to put that on the form.

If your service has been deactivated and you would like to reactivate your service there is a reactivation fee of \$29.99. If you have any questions please call customer service at 1-800-292-7748 or email us at Sales@spycentre.com
