TO OBTAIN WARRANTY SERVICE:

Company will not be liable for any incidental or consequential damages resulting from the improper use of this Product. This warranty is expressly in lieu of and supersedes any other warranties, expressed or implied. There are no warranties which extend beyond the description of the face hereof and no person, representative or firm is authorized to commit Company to further liability or obligation. This warranty gives you specific legal rights. You may have other rights which vary from state to state.

Oral Care Technologies, Inc. offers the opportunity to extend the original Limited Warranty for an additional Two (2) years. This offer is ONLY VALID for the retail purchaser and expires Ninety (90) days from the date of purchase. The cost to extend your warranty is \$27.50.
