

BASIC FUNCTIONS

BASIC FONCTIONS		
Power on	Press MFB for 2 seconds	
Power off	Press MFB for 3 seconds	
Reset pairing mode	Headphones powered on, press Vol+ & Vol- at the same time until LED turns purple	
Volume up	Press Vol+	
Volume down	Press Vol-	
Low latency on/off	Click MFB 4 times in standby mode	
Siri	Click MFB 3 times in standby mode	

Play/Pause	Press MFB once
Next Song	Press Vol+ for 1 second
Previous Song	Press Vol- for 1 second
Answer/End call	Press MFB once
Answer 2nd call & end current call	Long press MFB for 2 seconds
Redial last call	Press MFB twice
