



Couture Within Reach™ Consignment Agreement

I, _____, consign my merchandise for sale subject to the following:

1. Couture Within Reach™ accepts only authentic designer name label quality items – handbags, shoes, jewelry and accessories.
2. Couture Within Reach™ reserves the right to refuse your items if they do not meet our standard policies and supply and demand of our shoppers.
3. All consignment items must be authentic. Consignors should not submit replicas and counterfeit products/items to Couture Within Reach™.
 - a. A consignor's personal information may be requested by rights owners looking to trace the origin of counterfeit merchandise.
 - b. All handbags, shoes, jewelries and accessories must be authentic designer name labels.
 - c. Couture Within Reach™ reserves the right to keep and destroy any counterfeit merchandise if discovers when it believes a consignor is intentionally providing counterfeit merchandise.
 - d. If by chance an item is sold and found to be an imitation, you as the consignor agree to any damages Couture Within Reach™ may encounter.
4. All consignment items must be in new or gently used, in very good to mint conditions:
 - a. All items must be in wearable or usable condition
 - b. All items must be clean, free from smoke and other odors
 - c. All soles of the shoes should be cleaned
5. Your item(s) will be listed on cwrnyc.com and third-party sites (eBay, Etsy, Craigslist, depop, etc..) at the same time, wherever will sell first:
 - a. Prices are to be determined and agreed by Couture Within Reach™ and the consignor.
 - b. If item is sold via third-party sites, any associated transaction fees will be charged.
 - c. Items will be listed on both sites for 120 days.
 - d. The selling price will be reduced after 30 days by 25%, 45% after 60-day and 65% after 90 days.
6. All items are consigned on 25%/75% (Couture Within Reach™/Consignor) basis.
 - a. We do not charge a listing fee if your items are sold at our website, only merchant payment fee of 2.9%+0.30 (US) or 3.9%+0.30 (international), depending on the buyer's location, will be charged.
 - b. Any items sold on third-party sites will be charged the associated transaction fees. That means the consignors are responsible to pay or bear any third-party sites' listing fees and financial transaction (e.g. PayPal) fees (such costs will be deducted from the 75% share to Consignor).

7. Couture Within Reach™ will issue you a check as soon as we have received the cleared payment from the buyer. Couture Within Reach™ issues checks on the 18th day of every month for the shipping period beginning on the 1st of prior month to the last day of the previous month. For example, checks issued on April 18th would cover items shipped from March 15- April 15. Please allow 3 – 5 business days to receive a check. Commissions paid will include sales from the prior month less returns and cancellations.
8. Couture Within Reach™ does its best to protect all items on consignments. The consignor hereby agrees not to hold Couture Within Reach™ responsible for consigned items that are lost, stolen or damaged by any cause whatsoever.
9. Couture Within Reach™ reserves the right to modify or change the consignment agreement and policies at any time without prior notice. Consignment policies are posted online.
10. Please ship your package to us with tracking number and email it with the shipping company information to help@cwryc.com
