Air release :

Cover with absorbent sheets, spill-control pads or pillows. Apply detergents, soaps, alcohols or another surface active agent. Remove trapped material with suction hoses.

Occupational release :

Stop leak if possible without personal risk.

Reduce vapors with water spray. Small spills: Absorb with sand or other non-combustible material. Collect spilled material in appropriate container for disposal.

Large spills: Dike for later disposal. Keep unnecessary people away, isolate hazard area and deny entry. Stay upwind and keep out of low areas.
