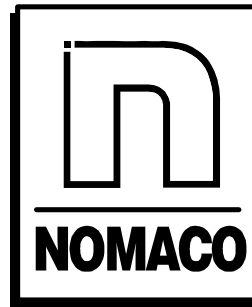

DESCRIPTION

Tuff Pad is a patented, custom engineered, Low Density Polyethylene (LDPE) closed cell foam with an integrally bonded outer layer for reinforcement and extended durability. This product was specifically designed for outdoor playgrounds. The outer layer adds extra protection to the foam inner layers and does not require additional jacketing.

Post Pad is custom engineered LDPE closed cell foam that has a resilient exterior called Nomahyde. Developed specifically for playground padding, Nomahyde coating is used for better resistance and is formulated with UV and flame retardant inhibitors for use indoor or outdoor.

Both Tuff Pad and Post Pad have a 90% slit for easy assembly.
