Detailed Method Description(s)

Pesticides by GC/MS/MS

Submitted samples for pesticide detection are extracted by a QuEChERS method. A sample is made homogenous either through grinding, blending, or mixing. Approximately 3 g of sample is weighed into extraction tubes and 12 mL water, 10mL of acetonitrile and 2 mL of hexane are added. The salt packet provided with the extraction tubes is added and mixed, causing the acetonitrile to separate from the water. The acetonitrile extract is cleaned using dispersive solid phase extraction (dSPE). The extracts are combined with analyte protectants and are injected into a GC/MS/MS for separation and quantification.
