THIS AGREEMENT is a release of the STUDENT'S RIGHTS TO SUE for injuries or death resulting from the rental and/or use of this equipment. STUDENT expressly assumes all risks of snorkeling, skin and/or scuba diving related in any way to the rental and/or use of this equipment.

The undersigned STUDENT acknowledges that he/she has examined and inspected the equipment leased and that is in good condition in every respect to ensure it is free from defects, including checking both the quality and quantity of air in any scuba cylinders rented. STUDENT agrees to return same to BEACH CITIES SCUBA CENTERS at its premises in the condition as received less ordinary wear and tear, and further agrees to pay such additional charges as may be made if not returned in clean condition. In the even the equipment is lost, damaged or destroyed while under lease to him/her, STUDENT agrees to pay all reasonable charges and costs thereof as imposed by BEACH CITIES SCUBA CENTERS.

STUDENT hereby acknowledges receipt of the equipment designated in this form, and if any of this equipment is to be used for scuba diving, that STUDENT is a certified scuba diver and/or student in a scuba diving course/program under the supervision of a certified scuba instructor. STUDENT also understands that BEACH CITIES SCUBA CENTERS and its employees, owner, officers, or agents (herein after "RELEASED PARTIES"), shall not be held liable or responsible in any way for any injury, death, or other damages to STUDENT or his family, heirs, or assigns which may occur as a result of rental and/or use of the equipment; or as a result of product defect, or the negligence of any party, including the RELEASED PARTIES, whether passive or active.

I _____ HAVE CAREFULLY READ AND UNDERSTAND THE ABOVE AGREEMENT. BY SIGNING THIS AGREEMENT, I EXEMPT AND RELEASE BEACH CITIES SCUBA CENTERS, AND ALL RELATED ENTITIES AS DEFINED ABOVE FROM ALL LIABILITY OR RESPONSIBILITY WHATSOEVER FOR PERSONAL INJURY, PROPERTY DAMAGE, OR WRONGFUL DEATH AS A RESULT OF RENTING AND/OR USING THE EQUIPMENT. HOWEVER CAUSED, INCLUDING BUT NOT LIMITED TO PRODUCT LIABILITY OR THE NEGLIGENCE OF THE RELEASED PARTIES WHETHER PASSIVE OR ACTIVE.
