Measures in the event of

- <u>Inadvertent contact with eyes:</u> rinse thoroughly with plenty of lukewarm water immediately; then consult ophthalmologist
- <u>Inadvertent ingestion:</u> do not induce vomiting. Rinse out and drink about one or two glasses of water. Then consult a doctor.
- <u>Discomfort on contact with skin</u>: immediately wash off with water and soap; skincare. Remove contaminated clothing and towels. If skin irritation persists, consult a doctor.
