### Limitations of Use

- Usage, maintenance and storage as per manufacturer's instructions.
- The hardware on the garments was tested to Clause 6.1 of EN 469:2005 (Flame Spread), but with the method modified by the procedure detailed in the Co-ordination of Notified Bodies 'Recommendation for Use' sheet No. 21-013, approved by Vertical Group 5 on 09/05/2006. The recommended method is to apply the flame to the outer surface of the region of clothing containing the hardware, if that hardware is concealed from flame in use, rather than to apply the flame directly to the hardware, as specified in EN 469. Using the procedure detailed above, all of the hardware on the garment meets the requirements of 6.1.6 of EN 469:2005, i.e. the hardware functions after the test.

### Observations

- The assembly at the hems of the garments included an anti-wicking fabric used in addition to the main assembly.
- The JW-P07 Coat and Trousers (size Small) meet the requirements of Annex B.1 and Annex B.2 of EN 469:2005 (Visibility) for area of retroreflective and fluorescent material, as required by Clause 6.14 of EN 469.
