#### **Potential Health Effects**

#### Inhalation

**Short term exposure:** Significant inhalation exposure is considered to be unlikely. Available data indicates that this product is not harmful. In addition product is unlikely to cause any discomfort or irritation.

#### Eye Contact:

**Short term exposure:** Exposure via eyes is considered to be unlikely. This product is a severe eye irritant. Symptoms may include stinging and reddening of eyes and watering which may become copious. Other symptoms such as swelling of eyelids and blurred vision may also become evident. If exposure is brief, symptoms should disappear once exposure has ceased. However, lengthy exposure or delayed treatment is likely to cause permanent damage.

This is a commercial product whose exact ratio of components may vary slightly. Minor quantities of other non hazardous ingredients are also possible.

# **SECTION 6 - ACCIDENTAL RELEASE MEASURES**

Accidental release: In the event of a major spill, prevent spillage from entering drains or water courses.
