This is a commercial product whose exact ratio of components may vary slightly. Minor quantities of other non hazardous ingredients are also possible.

## **SECTION 4 - FIRST AID MEASURES**

#### **General Information:**

## **SECTION 6 - ACCIDENTAL RELEASE MEASURES**

Accidental release: Minor spills do not normally need any special cleanup measures. In the event of a major spill, prevent spillage from entering drains or water courses. # **SECTION 10 - STABILITY AND REACTIVITY**
