RELEASE OF LIABILITY WAIVER

Assuming the risks, and agreeing to indemnify, TO FOREVER RELEASE AND DISCHARGE ALL LIABILITY from Maxx UAV LLC and their respective agents, employees, owners, volunteers, members, sponsors, promoters, and that I am giving up substantial legal rights. THIS RELEASE OF LIABILITY IS A CONTRACT WITH LEGAL AND BINDING CONSEQUENCES.

In consideration of my DJI Antenna Modification, I acknowledge the risks of this modification which could result in the loss of signal with the unmanned aerial aircraft and FULLY ASSUME THE RISKS ASSOCIATED WITH THE MODIFICATION, by way of example, and not limitation: the dangers of collision with pedestrians, vehicles, other aircrafts, and fixed or moving objects; the dangers arising from inadequate flight conditions, equipment failure, temperature, weather, THE RELEASEES' OWN NEGLIGENCE, the negligence of others; and the possibility of serious physical and/or mental trauma or injury, or death associated with flying.

For myself, my heirs, executors, administrators, legal representatives, assignees, and successors in interest (collectively "Successors") I HEREBY WAIVE, RELEASE, DISCHARGE, HOLD HARMLESS, AND PROMISE TO INDEMNIFY AND NOT TO SUE the Releasees and all sponsors, and promoting organizations, and public entities (the foregoing are also collectively deemed to be Releasees), FROM ANY AND ALL RIGHTS AND CLAIMS INCLUDING CLAIMS ARISING FROM THE RELEASEES' OWN NEGLIGENCE, which I have or which may hereafter accrue to me, and from any and all damages which may be sustained by me directly or indirectly in connection with, or arising out of, my participation or association with Maxx UAV LLC.

I agree to comply with all such rules, laws and regulations in regard to the laws set forth by the Federal Aviation Administration.

I accept responsibility for the condition and adequacy of my UAV (unmanned aerial vehicle) and my conduct in connection with piloting. I agree, for myself and my successors, that the above representations are contractually binding, and are not mere recitals, and that should I or my successors assert a claim contrary to what I have agreed to in this contract, the claiming party shall be liable for the expenses (including legal fees) incurred by the Releasees in defending the claims. This contract may not be modified orally, and a waiver or modification of any provision shall not be construed as a waiver or modification of any other provision herein or as consent to any subsequent waiver or modification. I consent to the release by any third party to Releasees and their insurance carriers of my name and medical information that may relate solely to any injury or death I may suffer arising from the DJI Antenna Modification. Every term and provision of this contract is intended to be severable. If any one or more of them is found to be unenforceable or invalid, that shall not affect the other terms and provisions, which shall remain binding and enforceable
