**Category 1:** Lip Products of all types (solid and liquid lipsticks, balms, clear or colored, etc.); Children's toys

**Category 2:** Body sprays (including body mist); Deo antiperspirant products (spray, stick, roll-on, underarm, deocologne, etc.)

**Category 3:** Body and face paint (for children and adults); Eye products of all types including eye care and moisturizer; Facial make up and foundation; Facial masks for face and around the eyes; Make-up remover for face and eyes; Nose pore strips; Wipes or refreshing tissues for face, neck, hands, body

**Category 4:** Fragranced bracelets; Hydroalcoholic and non-hydroalcoholic fine fragrance of all types (Eau de Toilette, Parfum, Cologne, solid perfume, fragrancing cream, aftershaves of all types, etc.); Ingredients of perfume kits and fragrance mixtures for cosmetic kits; Scent pads, foil packs; Scent strips for hydroalcoholic products

**Category 5:** All powders and talc (excluding baby powders and talc); Body creams, oils, lotions of all types; Foot care products (creams and powders); Insect repellent (intended to be applied to the skin)
