Category 1: Lip Products of all types (solid and liquid lipsticks, balms, clear or colored, etc.), Children's toys

Category 2: Body sprays (including body mist), Deo antiperspirant products (spray, stick, roll-on, underarm, deocologne, etc.)

Category 3: Body and face paint (for children and adults), Eye products of all types including eye care and moisturizer, Facial make up and foundation, Facial masks for face and around the eyes, Make-up remover for face and eyes, Nose pore strips, Wipes or refreshing tissues for face, neck, hands, body
