Category 1: Lip Products of all types (solid and liquid lipsticks, balms, clear or colored, etc.); Children's toys

Category 2: Body sprays (including body mist); Deo antiperspirant products (spray, stick, roll-on, underarm, deocologne, etc.)

Category 3: Body and face paint (for children and adults); Eye products of all types including eye care and moisturizer; Facial make up and foundation; Facial masks for face and around the eyes; Make-up remover for face and eyes; Nose pore strips; Wipes or refreshing tissues for face, neck, hands, body
