Category 1: Lip Products of all types (solid and liquid lipsticks, balms, clear or colored, etc.), Children's toys

Category 2: Body sprays (including body mist), Deo antiperspirant products (spray, stick, roll-on, underarm, deocologne, etc.)

Category 3: Body and face paint (for children and adults), Eye products of all types including eye care and moisturizer, Facial make up and foundation, Facial masks for face and around the eyes, Make-up remover for face and eyes, Nose pore strips, Wipes or refreshing tissues for face, neck, hands, body

Category 4: Fragranced bracelets, Hydroalcoholic and non-hydroalcoholic fine fragrance of all types (Eau de Toilette, Parfum, Cologne, solid perfume, fragrancing cream, aftershaves of all types, etc.), Ingredients of perfume kits and fragrance mixtures for cosmetic kits, Scent pads, foil packs, Scent strips for hydroalcoholic products

Category 9: All depilatories (including facial) and waxes for mechanical hair removal; Baby wash, bath, shampoo; Bar soap, Liquid soap; Bath gels, foams, mousses, salts, oils and other products added to bathwater; Body washes and shower gels of all types; Cleanser for face (rinse-off); Conditioner (rinse-off); Foot care products (feet are placed in a bath for soaking); Shampoo of all types, Shampoos for pets; Shaving creams of all types (stick, gels, foams, etc.)
