**Category 9:** All depilatories (including facial) and waxes for mechanical hair removal; Baby wash, bath, shampoo; Bar soap, Liquid soap; Bath gels, foams, mousses, salts, oils and other products added to bathwater; Body washes and shower gels of all types; Cleanser for face (rinse-off); Conditioner (rinse-off); Foot care products (feet are placed in a bath for soaking); Shampoo of all types, Shampoos for pets; Shaving creams of all types (stick, gels, foams, etc.)
