Category 2: Body sprays (including body mist), Deo antiperspirant products (spray, stick, roll-on, under-arm, deocologne, etc.)

Category 3: Body and face paint (for children and adults), Eye products of all types including eye care and moisturizer, Facial make up and foundation, Facial masks for face and around the eyes, Make-up remover for face and eyes, Nose pore strips, Wipes or refreshing tissues for face, neck, hands, body

Category 4: Perfumery products, Hydroalcoholic and non-hydroalcoholic fine fragrance of all types (Eau de Toilette, Parfum, Cologne, solid perfume, fragrancing cream, aftershaves of all types, etc.), Ingredients of perfume kits and fragrance mixtures for cosmetic kits, Scent pads, foil packs, Scent strips for hydroalcoholic products

Category 8: Intimate wipes, Tampons, Toilet paper (wet), Baby wipes

Category 9: All depilatories (including facial) and waxes for mechanical hair removal; Baby wash, bath, shampoo; Bar soap, Liquid soap; Bath gels, foams, mousses, salts, oils and other products added to bathwater; Body washes and shower gels of all types; Cleanser for face (rinse-off); Conditioner (rinse-off); Foot care products (feet are placed in a bath for soaking); Shampoo of all types, Shampoos for pets; Shaving creams of all types (stick, gels, foams, etc.)

Category 10A: Dry cleaning kits; Fabric softeners of all types including fabric softener sheets; Floor wax; Scented oil for lamp ring, reed diffusers, pot-pourri, liquid refills for air fresheners (non-cartridge systems), etc.; Hand dishwashing detergent (including concentrates); Hand wash laundry detergent (including concentrates); Hard surface cleaners of all types (bathroom and kitchen cleansers, furniture polish, etc.); Household cleaning products, other types including fabric cleaners, soft surface cleaners, carpet cleaners, furniture polishes sprays and wipes, leather cleaning wipes, stain removers, fabric enhancing sprays, treatment products for textiles (e.g. starch sprays, fabric treated with fragrances after wash, deodorizers for textiles), Ironing water (Odorized distilled water); Laundry pre-treatment of all types (e.g. paste, sprays, sticks); Machine laundry detergents with skin contact (e.g. liquids, powders) including concentrates; Toilet seat wipes
