#### 3. COMPOSITION/INFORMATION ON INGREDIENTS

# 4. FIRST AID MEASURES

## **5. FIRE FIGHTING MEASURES**

#### 6. ACCIDENTAL RELEASE MEASURES

Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Ensure adequate ventilation. **Methods and materials for containment and cleaning up:** Eliminate all ignition sources (no smoking, flares, sparks, or flames in immediate area). Keep combustibles (wood, paper, oil, etc.) away from spilled material. This material is classified as a water pollutant under the Clean Water Act and should be prevented from contaminating soil or from entering sewage and drainage systems which lead to waterways. Large Spills: Stop the flow of material, if this is without risk. Dike the spilled material, where this is possible. Use a non-combustible material like vermiculite, sand or earth to soak up the product and place into a container for later disposal. Following product recovery, flush area with water. Small Spills: Absorb with earth, sand or other non-combustible material and transfer to containers for later disposal. Wipe up with absorbent material (e.g. cloth, fleece). Clean surface thoroughly to remove residual contamination.


