Category 1: Lip Products of all types (solid and liquid lipsticks, balms, clear or colored, etc.)

Category 2: Deo antiperspirant products (spray, stick, roll-on, under-arm, deocologne, etc.)

Category 3: Body and face paint (for children and adults)
