In addition, the acquisition of Les Confections Stroma gives us greater operational flexibility to manage the market's upward fluctuations and to ensure better control of our schedules," says Quartz Co. The acquisition of Les Confections Stroma is part of the company's expansion program. It follows the February 2019 acquisition our long-time subcontractor

Confection Bécotte in Victoriaville. "In 2019 alone, we tripled our workforce and are still looking for new skilled workers," adds Jean-Philippe Robert.
