Preparation:

Base can be constructed of either poured slab or compacted gravel.

Concrete Base Foundation:

- 4" deep
- 4" outside perimeter of base
- Reinforce with 6" x 6" no. 10 WWM
- Compact sub-base soils to 95% of
- standard proctor (ASTM D698)

Aggregate Base Foundation:

- 6" deep
- 8" outside perimeter of base
- Compact sub-base soils to 95% of standard proctor
- Compact aggregate base to 95% of standard proctor (ASTM D698)

Zoning and Permits: Before you plan your project, learn about the necessary zoning requirements and rules for excavating and building in your area. No matter how small your project, be sure you obtain the necessary permits before you start construction.

Base

Know What's Below: Whether you are planning to do it yourself or hire a professional, smart digging means calling 811 before each job. Homeowners often make risky assumptions about whether or not they should get their utility lines marked, but every digging job requires a call – even small projects like planting trees and shrubs.



Course 1

Be sure your properly prepared base is level. Position basin on base and build your first course as shown. Courses are shown without basin in position.

Using a stiff brush, remove all debris and dust from each block surface to be glued.

Use top of basin as guide for radius blocks. Top course will have an approx. 1" space between block and basin.



Course 2

Continue to build each course as shown. Use adhesive on each block.



Course 3

Do NOT use adhesive here. See Course #4.



Course 4

<u>Do NOT glue this block (A), top or bottom.</u> Leave this block unglued for future electrical access.

STOP when you finish this course to add the catch basin.

Disconnect at this fitting to store

Add Catch Basin, Pump, and Hose

Follow catch basin manufacturers installation and assembly instructions.

- 1) Feed hose through catch basin opening.
- 2) Place catch basin in position.
- 3) Feed power cord in notch out back of the basin.

Feed cord through hose opening and out back of waterfall through cut block (A), see Course 4.





Course 6

Place tops and center. Lift to glue in place.



Course 7



Add the Spillway

Be sure to dry fit the spillway before securing with adhesive.

1) Bring spillway as far forward as possible.

2) Once you have spillway plumbed and in position, level spillway (shim as needed) and secure with adhesive. Use blocks as weights to hold in position while adhesive sets.





Connect the Spillway and Optional Light Kit

1) Add threaded fitting to spillway. Trim hose as needed to install flow control valve and connect hose to fittings, secure with PVC cement. Install optional light kit now. Feed power cord through cut block (A), see course #5.

2) Fill basin with water. Turn on pump and adjust water volume with flow control valve. Adjust so water does not overflow the pan.

3) Install screen and decorative rock after you have run the pump for a short while.



Final Step

DO NOT GLUE UPPER TOPS.

Place tops and center. For future access to spillway, <u>DO NOT</u> use adhesive.





IMPORTANT: Allow 72 hrs. for adhesive to set before use.

PLEASE NOTE: As with any concrete product, the age of the products can cause variations in color. Lighter colored Silver Creek tops are older and have cured more than newer, darker tops. Don't be alarmed. As tops age, their color will lighten and blend together.

IMPORTANT: DO NOT LET PUMP FREEZE! Be sure to remove the pump for inside storage during cold/freezing conditions.
