Women's facial creams, facial make-up (excluding eye cream), facial masks, hand cream, wipes are refreshing tissues for face, neck, body, hands.	5
Mouthwash and toothpaste.	6
Intimate wipes, baby wipes, insect repellent intended to be applied directly to the skin.	7
Make-up removers of all types (not including face cleansers), hair styling aids non-spray of all types (mousse, gels, leave-in conditioners, etc), nail care, all powders and talcs including baby powders and talcs.	8
Liquid and bar soap, depilatory, rinse-off conditioners, shampoos of all types including baby, facial cleansers, shaving creams, body washes, shower gels of all types, feminine hygiene pads and liners, other aerosols including air fresheners.	9

Hand and machine wash laundry detergents of all types including bleaches, other household cleaning products, dry cleaning kits, fabric softeners, hard surface cleaners of all types, pet shampoos, diapers, toilet seat wipes.	10
