<b>1</b>	Products applied to the lips: Lip products e.g. lipstick, lip balm; Childrens toys
<b>2</b>	Products applied to the axillae: Deodorant and antiperspirant products of all types; Body sprays/mists
<b>3</b>	Products applied to the face/body using fingertips: Eye products e.g. eye make-up, eye moisturizer; Facial make-up; Make-up remover; Nose pore strips; Wipes for face, neck, hands, body; Facial masks; Body and face paint
<b>4</b>	Products related to fine fragrance: Hydroalcoholic and non-hydroalcoholic fine fragrance of all types e.g. Eau de Toilette, Parfum, Cologne, solid perfume, fragrancng cream, aftershaves of all types; Ingredients of perfume and fragrance mixtures for cosmetic kits; Scent pads; Scent strips
<b>5A</b>	Body lotion products applied to the body using the hands (palms), primarily leave on: Foot care products e.g. creams, powders; Insect repellent for application to the skin; All powders and talc (excluding baby powders and talc)
<b>5B</b>	Face moisturizer products applied to the face using the hands (palms), primarily leave on: Facial toner; Facial moisturizers and creams
<b>5C</b>	Hand cream products applied to the hands using the hands (palms), primarily leave-on
<b>5D</b>	Baby creams, baby oils and baby talc: Baby cream/lotion, baby oil, baby powders and talc
<b>6</b>	Products with oral and lip exposure: Toothpaste; Mouthwash, including breath sprays; Toothpowder,strips, mouthwash tablets
<b>7A</b>	Rinse-off products applied to the hair with some hand contact: Hair permanent or other hair chemical treatments (rinse-off) e.g. relaxers, including rinse-off hair dyes
<b>7B</b>	Leave-on products applied to the hair with some hand contact: Hair sprays of all types e.g. pumps,aerosol sprays; Hair styling aids non sprays e.g. mousse, leave- on conditioners; Hair permanent or other hair chemical treatments (leave-on) e.g. relaxers, including leave-on hair dyes; Shampoo - Dry (waterless shampoo); Hair deodorizer

8	Products with significant anogenital exposure: Intimate wipes; Tampons; Baby wipes; Toilet paper (wet)
9	Products with body and hand exposure, primarily rinse off: Bar soap; Liquid soap; Shampoo of all type; Conditioner (rinse-off); Body washes and shower gels of all types; Baby wash, bath, shampoo; Bath gels, foams, mousses, salts, oils and other products added to bathwater; Cleanser for face (rinse-off); Shaving creams of all types e.g. stick, gels, foams; All depilatories (including facial) and waxes for mechanical hair removal; Foot care products (feet are placed in a bath for soaking); Shampoos for pets
10A	Household care excluding aerosol / spray products: Hand wash laundry detergent; Laundry pre-treatment of all types e.g. paste, sprays, sticks; Machine laundry detergents with skin contact e.g. liquids, powders; Fabric softeners of all types including fabric softener sheets; Ironing water; Hand dishwashing detergent; Hard surface cleaners of all types e.g. bathroom, kitchen cleansers, furniture polish; Toilet seat wipes; Household cleaning products, other types including fabric cleaners, carpet cleaners, furniture polishes, sprays and wipes, stain removers, treatment products for textiles e.g. starch sprays; Floor wax; Dry cleaning kits; Fragranced oil for lamp ring, reed diffusers, pot-pourri, liquid refills for air fresheners (non cartridge systems), etc..
10B	Household aerosol/spray products: Animal sprays applied to animals; Air freshener sprays, manual, including aerosol and pump; Aerosol/spray insecticides
11A	Products with intended skin contact but minimal transfer of fragrance to skin from inert substrate without UV exposure: Feminine hygiene conventional pads, liners, interlabial pads; Diapers (baby and adult); Adult incontinence pant, pad; Toilet paper (dry)
11B	Products with intended skin contact but minimal transfer of fragrance to skin from inert substrate with potential UV exposure: Tights with moisturizers; Scented socks, gloves; Facial tissues (dry tissues); Napkins; Paper towels; Wheat bags; Facial masks (paper/protective) e.g. surgical masks not used as medical device; Fertilizers, solid (pellet or powder)
12	Products not intended for direct skin contact, minimal or insignificant transfer to skin: Candles of all types ; Laundry detergents for machine wash with minimal skin contact (e.g. Liquid tabs, pods); Automated air fresheners and fragrancing of all types e.g. concentrated aerosol with metered doses, plug-ins, electrical, incense, liquid refills (cartridge); Air delivery systems; Cat litter; Cell phone cases; Deodorizers/maskers not intended for skin contact e.g. fabric drying machine deodorizers, carpet powders; Fuels; Insecticides e.g. mosquito coil, paper, electrical, for clothing, excluding aerosols/sprays; Joss sticks or incense sticks; Dishwash detergent and deodorizers - for machine wash; Olfactive board games; Paints; Plastic articles (excluding toys); Scratch and sniff; Scent pack; Scent delivery system (using dry air technology); Shoe polishes; Rim blocks (Toilet)
