### Section 4 - First Aid Measures

### **General Information:**

## **Section 6 - Accidental Release Measures**

Accidental release: In the event of a major spill, prevent spillage from entering drains or water courses. Wear full protective clothing including eye/face protection. Suitable materials for protective clothing include barrier laminate, butyl rubber, neoprene rubber, PVC, Viton and Nitrile.
