The treatment area must be irrigated with up to 4 mm of water immediately after application. Inspect treatment areas for continuing activity. If required, repeat applications may be made at 2 month intervals up to a maximum of 5 applications per year. In domestic turf situations, use is only by authorised lawn care specialists, professional pest managers or persons with relevant chemical handling certification.
External surrounds of buildings and structures including: gardens, lawns, ant nests and trails	Nuisance Ants	75 - 150	0.75 – 1.5	Apply SAS PRO <sup>®</sup> Professional Granule Ant Killer to areas where ants are active. Sprinkle evenly over the area to be treated. Where possible apply directly on and around ant nests or trails. Reapply as necessary. Use high rate for heavy infestations and for maximum residual control. Use the low rate for maintenance situations or to control light infestations. When applied to pavers, sweep excess product into cracks for best control. In domestic turf situations, use is only by authorised lawn care specialists, professional pest managers or persons with relevant chemical handling certification.

**PROTECTION OF WILDLIFE, FISH CRUSTACEANS AND ENVIRONMENT**

**PROTECTION OF PETS AND LIVESTOCK**

Before treatment, remove animals and pets from the areas to be treated. Cover or remove any open food and water containers. Keep away from domestic pets, especially dogs. If dogs eat the granules, contact your veterinary surgeon immediately. Use with caution around pets – ensure product is well dispersed i.e. swept in between pavers, cracks and crevices and disperse into soil and/or lawn. Cover or remove fishponds, aquariums etc before application. DO NOT apply SAS PRO<sup>®</sup> Professional Granule Ant Killer within 2 metres of a fishpond or water containing fish or aquatic species. DO NOT graze treated turf or feed turf clippings from any treated area to poultry or livestock.

**STORAGE AND DISPOSAL**

Store in the closed, original container in a cool, well-ventilated area. Do not store for prolonged periods in direct sunlight. Triple or preferably pressure rinse containers before disposal. Do not dispose of undiluted chemicals on site. If recycling, replace cap and return clean containers to recycler or designated collection point. If not recycling, break, crush, or puncture container and deliver to an approved waste management facility. If an approved waste management facility is not available, bury the empty packaging 500 mm below the surface in a disposal pit specifically marked and set up for this purpose clear of waterways, desirable vegetation and tree roots, in compliance with relevant Local, State or Territory regulations.
