3. Hazards identification

Poisons Schedule: None allocated.

4. First-aid measures

Inhalation: Remove victim from area of exposure - avoid becoming a casualty. Seek medical advice if effects persist.

Skin Contact: If skin or hair contact occurs, immediately remove any contaminated clothing and wash skin and hair thoroughly with running water. If, irritation occurs seek medical assistance.

Eye Contact: If in eyes, hold eyelids apart and flush the eye continuously with running water. Continue flushing for at least 15 minutes. Seek medical treatment if effects continue after first aid treatment

Ingestion: Rinse mouth with water. If swallowed, do NOT induce vomiting. Give a glass of water. Seek medical advice.

5. Fire-fighting measures

Specific Hazards: Combustible liquid.

Fire-fighting advice: On burning will emit toxic fumes, including those of oxides of carbon. Fire fighters to wear self-contained breathing apparatus and suitable protective clothing if risk of exposure to vapour or products of combustion.

Suitable Extinguishing Media: Water fog (or if unavailable fine water spray), foam, dry agent (carbon dioxide, dry chemical powder).

6. Accidental release measures

Slippery when spilled. Avoid accidents, clean up immediately. Wear protective equipment to prevent skin and eye contact and breathing in vapours. Work up wind or increase ventilation. Contain - prevent run off into drains and waterways. Use absorbent (soil, sand or other inert material). Collect and seal in properly labeled containers or drums for disposal.

7. Handling and storage

Handling advice : Avoid skin and eye contact and breathing in vapour.

Storage advice: Store in a cool, dry, well ventilated place and out of direct sunlight. Store away from incompatible materials described in Section 10. Keep containers closed when not in use check regularly for leaks.
