

OFF-LICENCE

*Sections 17 to 20, and 64, Sale and Supply of Alcohol Act 2012
Endorsed under section 40*

PURSUANT to the Sale and Supply of Alcohol Act 2012 (the **Act**), **Giftbox Boutique NZ Limited** is authorised to sell alcohol remotely from (but not on) the premises situated at 13-15 Dyer Street, Raumanga, Whangarei, and known as "**Giftbox Boutique**", to any person for consumption off the premises.

CONDITIONS

This licence is subject to the following conditions:

- (a) No alcohol sold is to be delivered on Good Friday, Easter Sunday or Christmas Day or before 1.00 pm on Anzac Day.
- (b) (i) Alcohol may be sold at any time, with the following restriction,
(ii) Delivery must not take place between the hours of 11.00 pm to 6.00 am
- (d) The whole of the premises is undesignated.
- (e) That no direct sales may be made at 13-15 Dyer Street, Raumanga, Whangarei.
- (f) The following information must be displayed on the internet site in a prominent place, and in any catalogue used by the licence holder, and on every receipt issued for any alcohol sold via the internet site:
 - (i) The licence holders name
 - (ii) The licence number
 - (iii) The expiry date of the licence.
- (g) the following steps must be taken to verify that people are over the purchase age:
 - (i) In the case of an order made using an internet site or telephone order the prospective buyer must make a declaration that he or she is 18 years of age or over; and that the prospective receiver is also 18 years of age or over.
 - (ii) This declaration must occur when the prospective buyer first commences the order process; and
 - (iii) Again, immediately before the sale of alcohol is completed.

THE LICENSED PREMISES

The sale, supply or consumption of alcohol is authorised in the premises situated at 13-15 Dyer Street, Raumanga, Whangarei, or more precisely identified as outlined in a plan date stamped as received by the Whangarei District Licensing Committee on 17 September 2019.

DISPLAY OF LICENCE

A copy of this licence must be displayed on the website so as to be easily read by people entering the website.

DURATION

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force -

- (a) either—
 - (i) until the close of the period for which it was last renewed; or
 - (ii) if it has never been renewed, until the close of the period of 12 months after the day it was issued; but
- (b) if an application for the renewal of the licence is duly made before the licence would otherwise expire, either—
 - (i) until the close of the period of 3 years after the period for which it was last renewed; or
 - (ii) if it has never been renewed, until the close of the period of 4 years after the day it was issued.
