This is to certify that the live plants which this certificate accompanies have been produced and Maintained under a regular inspection program administered by the Georgia Department of Agriculture in accordance with the Entomology Act of 1937 and regulations promulgated thereunder.

Compliance Agreements

Japanese Beetle Harmonization Plan - Category 1: Japanese Beetle Harmonization Plan - Category 1: The rooted plants (or crowns) were produced in an approved Japanese beetle free greenhouse or screenhouse as provided in the U.S. Domestic Japanese Beetle Harmonization Plan.

Japanese Beetle Harmonization Plan - Category 2: The plants have been found to be free from Japanese beetle (*Popillia japonica*) on the basis of a container accreditation program, as provided in the U.S. Domestic Japanese Beetle Harmonization Plan.

Tropical Spiderwort Compliance: The regulated articles accompanied by this permit have met the entry requirements for the North Carolina Exterior Quarantine for Tropical Spiderwort. The above nursery is under compliance agreement with the Georgia Department of Agriculture Plant Protection Section and has been inspected for freedom of Tropical Spiderwort.

Texas Certification: The horticultural products in this shipment have met the inspection requirements for entry into the state of Texas and are apparently free of insect pests and diseases. The products comply with the Texas Department of Agriculture European Corn Borer Quarantine (Title 4, Part 1, §19.112).

Nematode Compliance: All parts of plants produced below ground or soil level and all plant cuttings for propagation were grown in areas found apparently free from, or maintained in a manner that would prevent infestation by Burrowing and Reniform Nematodes (Calif. Sec. 3271). Current Nematode Assay Results may be provided on request.

European Corn Borer Compliance: The facility, the construction thereof, and the manner of handling, maintaining and growing the products, all parts of plants produced below ground or soil level and all plant cuttings for propagation were grown in areas found apparently free from, or maintained in a manner that would prevent infestation of European corn borers (Calif. Sec. 3263).

Oregon Certification: The horticulture products which accompany this certificate comply with Oregon Department of Agriculture Japanese Beetle Quarantine and the Oregon Department of Agriculture Glassy Winged Sharpshooter Quarantine.

Puerto Rico Certification: The horticultural products in this shipment are apparently free of sand, soil, earth and other foreign matter, insect pests, and diseases.

Washington Certification: The horticulture products which accompany this certificate comply with Washington State Permit # JB10-15; the Washington Department of Agriculture European Corn Borer Quarantine (WAC 16-478-010), and the Washington Department of Agriculture Purple Nutsedge Quarantine (WAC 16-752) are free from these pests.

California Compliance: The agricultural products in this shipment comply with the California Code of Regulations, Title 3, Sections 3263 (European Corn Borer), 3271 (Burrowing and Reniform Nematodes), 3280 (Japanese Beetle) and are apparently free of insect pests, weeds, and diseases. The facility, the construction thereof, and the manner of handling, maintaining and growing the products, all parts of plants produced below ground or soil level and all plant cuttings for propagation were grown in areas found apparently free from, or maintained in a manner that would prevent infestation of European corn borers.
