# President's Report

The Annual Report gives us an opportunity to reflect on the achievements and activities of Craft + Design Canberra throughout the year. This is my first President's report since joining the team in 2023, and I find myself impressed with the incredible talent and world class standard of work from our members and staff. I would like to acknowledge the major achievements of our predecessors in delivering innovative exhibitions, programs, and festivals. I stand on your shoulders.

When you last received this report, we were known as Craft ACT: Craft + Design Centre. You may have noticed our new name — welcome to the first report from Craft + Design Canberra. This name was adopted to reduce public confusion, as our evaluation results showed that people believed the Design Canberra Festival and Craft ACT were perceived as separate organisations. Craft ACT was also perceived to be an arm of artsACT, and therefore assumed to be completely government funded, rather than a not-for-profit organisation, partially funded by government. To choose a new name we engaged in an extensive consultation with our members, through ThinkPlace and Inklab. So far, our new name has been met with positivity, and we look forward to building on that momentum.

But first, I want to reflect on the impressive year that was. In 2023 Craft + Design Canberra: hosted 17 diverse, challenging and beautifully crafted exhibitions; received a commendation from the Canberra Region Tourism Awards for the 2022 Design Canberra Festival; created a new workshop space for community engagement; organised artist studio visits through the Craft + Design Canberra Anytime Program; changed the organisational structure and increased wages, in line with NAVA (National Association for the Visual Arts) codes of practice, and government regulations; revisited the Constitution, which was last reviewed in 2015, and will be voted by members at the 2024 AGM; advocated for affordable insurance for our members; collaborated with other art organisations on the Kingston Art Precinct project; and acknowledged two of our Accredited Professional Members, Jennifer Kemarre Martiniello (Arentee) and Kirstie Rea, who were honoured with the title Craft Masters of the Asia Pacific Region by the World Craft Council, which is an outstanding achievement.

Craft + Design Canberra started the year with the *Emerging Contemporaries* exhibition, which highlighted the best work from recent graduates, demonstrating the depth and range of new artists and
