ASPIRE GRILLS AND CABINET LIMITED LIFETIME WARRANTY

ADBO WORLD warrants your ASPIRE grill and cabinet to be free from defects in material and workmanship under normal residential use.

LIMITED LIFETIME WARRANTY

ADBO WORLD ASPIRE tube burners, stainless steel grill, cast iron hotplate, and stainless-steel fire box are warrantied for as long as you are the original owner of the ASPIRE grill. The warranty is not transferable. This warranty excludes discoloration, surface scratches, weather and atmospheric-related staining, and minor surface rust and oxidation which are normal conditions and to be expected with any outdoor product. The actual part will be repaired or replaced, free of charge, with the owner paying for all other costs, including labor and freight. Any usage of hard detergents or commercial cleaning chemicals to clean the grill will void the warranty.

THREE-YEAR LIMITED WARRANTY

ADBO WORLD ASPIRE cast brass side burner, infrared back burner, knobs, knobs base, brass valves, drip pans, tamers, and warming rack are covered under the warranty for THREE (3) YEARS under normal residential use from the original date of purchase. The actual part will be repaired or replaced, free of charge. If the part is not covered by the 1-year or 3-year warranty it is up to the original owner to pay for the part(s) and all other costs, including labor and freight.

ONE-YEAR FULL WARRANTY

ADBO WORLD warrants its ASPIRE grill, all their component parts, ignition system (excluding batteries), and electronic components (including lights and thermometers) to be free from defects in materials and workmanship under normal residential use for a period of ONE (1) YEAR from the original date of purchase. ADBO WORLD will repair or replace, at its sole discretion, any part(s), which fails or is found to be defective during the warranty period, at no cost to the original purchaser. Warranty service must be performed by a ADBO WORLD authorized representative during normal business hours. As long as you are the original purchaser, all the warranties will be honored. Warranties are not transferable.

WARRANTY LIMITATIONS and EXCLUSIONS

This warranty applies to the original purchaser(s) for products sold in the Australia and operated and maintained as intended for single-family residential usage. This warranty is valid only with original proof of purchase, shall commence on the date of purchase, and shall terminate (both as to original and any replacement products) on the anniversary date of the original purchase date of the product stated on the above schedules. This warranty covers defects in materials and workmanship. This warranty does not cover parts that become defective as a result of negligence, misuse, use not in compliance with the Installation Instructions and Owner's Manual, accidental damage, natural disaster, improper handling, improper storage, improper installation, lack of required routine maintenance, electrical damage, local gas impurities or failure to protect against combustibles. Modifications to products that are not specifically authorized will cancel this warranty in full. Accessories, parts, valves, etc. when used must be ADBO WORLD products or this warranty is void. Warrantied items will be repaired or replaced at ADBO WORLD'S sole discretion. This warranty does not apply to rust, corrosion, oxidation, or discoloration unless the affected part becomes inoperable. The use of hard cleaning agents or degreasers outside the grill can damage the finish and void the warranty. ADBO WORLD will not be held liable for any negligence due to misuse by the original owner or otherwise. The ceramic paint for the Black Grill will be only covered for 2 years but the use of hard detergents can and will delete the warranty.

This warranty does not cover labor or labor-related charges, except as provided by separate specific written programs from ADBO WORLD. All repair work must be performed by a qualified and certified professional service person and requires prior approval by ADBO WORLD.

ADBO WORLD may require the defective product or part to be returned to the factory to determine the cause of (the) failure. ADBO WORLD will pay freight charges if the product or part is determined to be defective. This warranty does not cover breakage in shipment from our (independent) distributor to its customer(s) if the damage is determined to have occurred during that shipment.

This warranty specifically excludes liability for indirect, incidental, or consequential damages. Some provinces do not allow the exclusion or limitation of incidental or consequential damages, so the above exclusion may not apply to you. This warranty gives you specifi egal rights, and you may have other rights that may vary from pr e to province.

In the event of any warranty replacement, all removal, replacement, installation, and shipping costs are the responsibility of the grill owner.
