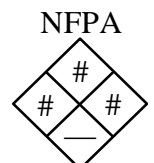

Section 6 - Accidental Release Measures

Spill /Leak Procedures: Ventilate area of leak or spill. Remove all sources of ignition. Wear appropriate personal protective equipment. Isolate hazard area. Contain and recover liquid when possible. Use non-sparking tools and equipment. Collect liquid in an appropriate container or absorb with inert material and place in chemical water container. Do not use combustible materials such as sawdust. Do not flush to sewer

Containment/Cleanup: For large spills, dike far ahead of liquid spill for later disposal. Do not release into sewers or waterways.

Engineering Controls:

Ventilation: Provide general or local exhaust ventilation systems to maintain airborne concentrations below OSHA PELs (Sec. 2). Local exhaust ventilation is preferred because it prevents contaminant dispersion into the work area by controlling it at its source.

Administrative Controls:
