

THE BREAKTHROUGH MEET & GREET SWEEPSTAKES

Official Sweepstakes Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.

1. Eligibility

The **Breakthrough Meet and Greet Sweepstakes** (the "Sweepstakes") is open to legal residents of the (50) United States and the District of Columbia who are at least eighteen (18) years old at the time of entry. Employees of Scott Brick Productions, Inc. dba Brick By Brick Audiobooks and other companies associated with the promotion of the Sweepstakes, and their respective parents, subsidiaries, affiliates and advertising and promotion agencies as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible. The Sweepstakes is subject to federal, state and local laws and regulations.

2. Sponsor

5. How to Enter

Via Email: Send an email to contests@brickbybrickaudiobooks.com and include: your full name, mailing address, contact phone number and date of birth.

Via Mail: This alternative method of entry will be available for the entire Sweepstakes Period. On a 3x5 card, handprint your full name, complete address, phone number (including area code) date of birth, email address (optional) along with required trivia Sweepstakes answer/s and mail in an envelope with proper postage affixed to: 11271 Ventura Blvd., Suite 315, Studio City, California, 91604. Mail-in entries must be hand-printed and mailed in separately. All mail-in entries must be postmarked by July 6, 2018 and received by July 10, 2018.

Limit one (1) entry per person, per email address, and per household for the duration of the Sweepstakes Period, regardless of method of entry. 6. Prize Drawing

On or about July 11, 2018, the Sponsor will select a potential Grand Prize winner in a random drawing from among all eligible entries received. The odds of being selected depend on the number of entries received. The Sponsor will attempt to notify the potential winner via telephone or email on or about July 13, 2018. If the potential winner cannot be contacted within five (5) days after the date of the first attempt to contact him/her, the Sponsor may select an alternate potential winner in his/her place at random from the remaining non-winning, eligible entries.

7. Winner Notification

The potential Grand Prize winner will be notified by email, mail or phone. Each potential Grand Prize winner will be required to complete, electronically sign and submit a Declaration of Compliance within five (5) days of the date notice or attempted notice is sent, in order to claim his/her prize. If a potential winner cannot be contacted, or fails to submit the Declaration of Compliance within the required time period (if applicable), or prize is returned as undeliverable, potential winner forfeits prize. Any attempt by any person to damage the website or undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and, should such an attempt be made, the Sponsor reserves the right to seek damages (including attorney's fees) and any other remedies from any such person to the fullest extent permitted by law.
