7. HANDLING AND STORAGE

Precautions for Safe Handling

Avoid contact with skin and eyes. Avoid formation of mist or respirable particles. Provide appropriate exhaust ventilation at places where mist or vapors are formed. Normal measures for preventive fire protection. Keep away from open flames and heated surfaces above 200 °C (392 °F).

Eye/face protection

Skin protection

Handle with gloves. Gloves must be inspected prior to use. Use proper glove removal technique (without touching glove's outer surface) to avoid skin contact with this product. Dispose of contaminated gloves

after use in accordance with applicable laws and good laboratory practices. Wash and dry hands.
