Sections 17 to 20, 40 (remote sales) and 64, Sale and Supply of Alcohol Act 2012

PURSUANT to the Sale and Supply of Alcohol Act 2012, **Le Gastronome (2017) Limited** is authorised to sell alcohol from the premises situated at 51 Riverlea Road, Riverlea, Hamilton 3216 and known as **"La Cave"**.

CONDITIONS: This Licence is subject to the following conditions:

- a) Alcohol may be sold or supplied only on the following days and during the following hours:
 - Monday to Friday, from 9.00am to 9.00pm
 - Saturday, from 9.00am to 5.00pm
 - Sunday, from 9.00am to 4.00pm
- b) No alcohol is to be sold on the premises on Good Friday, Easter Sunday, Christmas Day, or before 1 pm on Anzac Day.
- c) No alcohol may be sold other than: beer, mead, fruit, vegetable or grape wine, that complies with the appropriate New Zealand food standards; or a food flavouring, prepared for culinary purposes, that is unsuitable for drinking undiluted.
- d) The area where alcohol is to be sold is described in the plan date stamped as received by the District Licensing Committee on 17 August 2022. The only area permitted within that plan, as an area for the display and promotion of alcohol pursuant to section 112 is a separate temperature-controlled cellar room sited against the eastern wall within the store. The single alcohol area is divided into 2 sub-areas.
- e) The entire premises is undesignated.
- f) A properly appointed certificated, acting or temporary manager must be on duty and on the premises at all times when the premises is open for the sale and supply of alcohol. If a duty manager is not present, then there must be no alcohol sales and a notice displayed advising the public of this fact.
- g) A manager's register (as required by s.232 of the Act) is to be maintained and available on site.
- h) The licensee must ensure all staff receive training in their responsibilities and obligations under the Sale and Supply of Alcohol Act 2012
- i) There must be no sale or supply of alcohol to minors or intoxicated persons and there must be appropriate signs detailing these restrictions at every point of sale.
- j) The Licensee must ensure the following are displayed.
 - i) A sign to be seen from outside the principal entrance stating the ordinary hours of business during which the premises will be open for the sale of alcohol.
 - ii) A copy of the original licence with all the conditions, just inside the principal entrance so persons entering can read it.
 - iii) A sign in a prominent place identifying the duty manager.

Remote Sale Conditions

- k) Alcohol may be sold remotely at any time, on any day.
- l) Alcohol must not be delivered on Good Friday, Easter Sunday, Christmas Day, or before 1 pm on Anzac Day, or between 11:00pm and 6:00am the following day.
- m) The licensee must take reasonable steps to verify that the buyer and the receiver of an alcohol delivery is not under 18 years of age, and that the receiver (where present) is not intoxicated.
- n) A copy of the licence must be displayed on the La Cave's internet site in a prominent place.
